

• After extensive discussion between the TJRG EXCOM and the TJRG Reunion Committee we have weighed all the variables for the current Corona Virus (COVID-19) pandemic and decided on a second suspension of reunion planning until July 20, 2020 for the October 2020 reunion in Newport, RI. Right now, there are still too many unknowns and the vendors we were negotiating and contracting with are still largely shut down. Slowly the Economy is now starting to return, but it is too early in this process to properly plan. Additionally, the Naval Base is still closed with major restrictions. We are unable to determine the safety of the reunion for our membership at this stage in the pandemic. We estimate that two months are needed to plan the reunion at an accelerated pace, should the

decision be made after extensive evaluation in late July 2020 to proceed with the reunion.

• OTHER GREAT NEWS! I have posted the now famous painting of The Battle of Brandon Bay, by Mr. Dale Byhre, because we (the TJRG) have corrected history that was suppressed and distorted for political reasons during the 1972-1973 time frame. Both the Naval Heritage and Historical Command Main Museum in Washington D.C. and the United States Naval Academy in Annapolis, MD have stood up presentations in their museums to

display the Naval Operations of the era accurately. Thanks to Tom and Catherine Warner that view this and informed me. Mr. Chad James and the distinguished gentlemen of his era are in the process of correcting the historical record for the Tonkin Gulf Incident of early August 1964 as to what actually happened by those who fought that running action for about three days. A detailed timeline narrative from official records interwoven from Eye Witness Statements and available photos and video footage will be submitted later this year to key Naval Commands. In the future this will be submitted to the appropriate Naval Commands with Mr. Dale Byhre's now famous painting of 'Fateful Encounter'; 'USS Turner Joy (DD-951) engaging hostiles, 4 August 1964'. Ongoing Note. VETERANS REGULATORY INFORMATION UPDATE-Blue Water Navy Veterans are NOW entitled to a presumption of service connection for conditions related to Agent Orange. The extension of the presumption is a result of Public Law 116-23, the Blue Water Navy Vietnam Veterans Act of 2019, signed into law By President Donald J. Trump on June 25, 2019. The law takes effect on January 1, 2020. Veterans with questions about benefits or filing a claim can visit the VA Agent Orange website

This Picture was taken at the Grande Island Rest and Recreation area near Subic Bay, area in the late April, 1973 or early May,1973 time frame. The entire crew had been under an 'enormous strain for 8 consecutive months in multiple facets of Naval Operations, carrying out Foreign Policy in the Fighting to Leave policy of the Vietnam War. This picture is a clear representative of how much R & R was needed by the 1972-1973 combat crew of the USS Turner Joy (DD-951).

ONGOING SPECIAL THANKS: Chad James continues to do a "spectacular job in correcting the history" to actual events in the famed Tonkin Gulf Incident of August 2-4, 1964. We are tentative planning the Naval War College symposium for the future, if possible. Chad was a RD2 at the time and his efforts along with other eye witness of the time have done much to correct the "political misconceptions" created long ago. We intend to stay on this path and correct the records at the Naval War College and other Naval Commands with hard incontrovertible data from official records. Chad and other eye witnesses have made a lasting inroad to correct the historical record. Worth mentioning Again! Good Job Gentlemen! BZ!

TAPS: It is with Great Regret we report the following shipmates who have passed on:

BT2 Jim Shane passed away on 1/28/2020 as reported by his wife, Becky! Jim was onboard during the 1971 to 1974 time frame. Jim and his wife lived in Florida!

MM2 (later MMCS USN RET) Walter Parrish passed away in February, 2020 as reported by MM2 Raymond Frakes. Walter was onboard from 1959 to 1964.

MM3 Richard "Dick" Kissinger passed away in late December 2019. Dick was onboard from 1968 to 1970. He was Interred in Skyview Memorial Park in Tamaqua, PA. He was a huge Penn State COLLEGE football fan!

RD2 Iverson Smith passed away in 2014 at age 77. He was onboard during the 1963-1966 time frame. We had trouble confirming his death, but finally was able to confirm it. Iverson was one of the key eye witnesses during the Tonkin Gulf Incident on early August 1964. He was well respected by The Officers and Men of the USS Turner Joy.

GMG2 Robert J. Murray USN was killed in a motorcycle accident on May 22nd, 1965. He was onboard during the 1962-1965 time fame. Reported by his widow on the Internet after 55 years.

LT Roger E. Tetrault (later CAPT USNR Ret) passed away suddenly on January 27th, 2020. Roger had graduated from the Naval Academy in June 1963 and later served on the USS Turner Joy as CIC Officer. Later, Roger became a pilot in 1965, earning his wings and not only saw combat from the deck of the USS Turner Joy, BUT FROM THE AIR and DID TWO COMBAT TOURS IN Vietnam. Later leaving the Navy, he earned advanced degrees and worked in the Defense Industry and served in the U.S. Naval Reserve. In 2005, Roger was awarded the NASA Distinguished Public Service Medal. In 2013, Roger was selected from over 40,000 alumni of the Naval Academy among living alumni as the 55th most distinguished Graduate of that institution. Roger is survived by his wife of 30 years, Linda and two sons and one daughter and their families and grandchildren. A celebration of life was made Roger at the Peace River Botanical & Sculpture Gardens in Punta Gorda, FL on February 17, 2020. His fellow Officers and the Men he led considered him a "Fine Officer"!

TAPS FOR A NON-USS TURNER JOY CREWMEMBER:

ADMIRAL James L. Holloway III passed away on November 26, 2019 at age 97 years old. ADM Holloway graduated from the Naval Academy, class of 1943. He served in destroyers in WWII In the North Atlantic and in the North African Waters on convoy duty and later in the Pacific where he participated in the Battle of Saipan, the Battle of Tinian, and the Battle of Leyte Gulf [specifically in the Battle of Surigao Strait]. He was one of the two torpedo director officers credited with sinking the Japanese Battleship IJN Yamashiro at the Battle of Surigao Strait on October 25, 1944. He was serving in the USS Bennion (DD-662) at the time. After WWII, he became a Naval Aviator and flew two combat tours in F9F Panther's in the Korean War. He commanded two fighter squadrons. He also commanded an Attack squadron and covered the Landings in Lebanon in 1958. Later he commanded the USS Enterprise (CVAN-65) from 1965 to 1967, and was one of the first nuclear engineering qualified Naval Aviators in the US Navy. ADM Holloway later established the Navy's Nuclear-Powered Carrier Program from 1968 to 1970. In 1970, then RADM Holloway commanded the Carrier Striking Force in 6th Fleet. In 1972, then VADM Holloway took command of the 7th Fleet in combat Operations in North and South Vietnam. Our own Ed Briggs served under then VADM Jim Holloway as ACOS and later COS! Ed, Please Correct me if I am in error about those assignments!. During his tenure of 7th Fleet Commander, he participated in and eventually led a Cruiser-Destroyer Gunfire and Missile strike force during the Battle of Haiphong Harbor. As 7th Fleet Commander, he personally recognized the USS Turner Joy in a 13 JUN 73 Naval message for our historic contributions to the Vietnam War, which is published in the 1972-1973 USS Turner Joy cruise book. He then became Vice CNO from late 1973 to mid 1974. He was CNO from 1974-1978. He received over 40 Military decorations and medals! He was buried at the United States Naval Academy cemetery with full Military honors in December 2019. He was one of the most distinguished Naval Officers this country has ever produced.
