

The extension of the presumption is a result of Public Law 116-23, the Blue Water Navy Vietnam Veterans Act of 2019, signed into law By President Donald J. Trump on June 25, 2019. The law took effect on January 1, 2020. ## ACTUAL COMBAT VIDEO OF THE LAST NAVAL ROUND FIRED IN THE VIETNAM WAR BY THE USS TURNER JOY (DD-951).

Our shipmate; HT 2 Kenny Roice USN filmed the "Last Naval Round fired" by the USS Turner Joy (DD-951) in the Vietnam War. Many crew members remember this a bit differently so we in the EXCOM purchased two DVD's of the Vietnam War filmed by Kenny. When the last fire mission was transmitted by our ANGLICO Airborne Spotter, LTJG Dave Pfahler USN, the OS's and the Gunnery Liaison Officer (GLO) in Combat Information Center (CIC) plotted this target on a Universal Mercator Grid (UTM) Combat Chart with 1,000 meter grid squares to set up for an indirect Fire Mission of 'One Round ONLY'! Commander 7th Fleet (C7F), VADM Jim Holloway USN, directed us to fire that last round to impact at precisely 0800 H, (0000Z GMT) on 28 January 1973. The video also shows our one round fire mission hitting the target approximately 20,750 yards away [45 second Time of Flight] in the thick Industrial haze and the additional smoke of being in a heavy combat; just below the Demilitarized Zone (DMZ) for 13 consecutive days. The video shows a somewhat large secondary explosion of the enemy target in the thick Industrial haze, which was a 'Suspected Ammunition Dump' in the DMZ. Kenny was standing next to our Captain, CDR Robert (Rob) H. Pidgeon USN who was directing Kenny in the video shoot. The video also shows the empty shell casings (about 70 of them, from the two previous Fire Missions) that was moved forward of the Gun Target Line of the barrel by the Gunner's Mates, so the XO could pick up that last powder casing of the Last Naval Round Fired in the Vietnam War. A copy of the video has gone to our webmaster along with all the documentation the EXCOM could find and will be a historical contribution for the USS Turner Joy. In the near future, another copy of the video and supporting documentation will be sent to the USS Turner Joy for an historical exhibit on the ship itself. The painting by Dale Byhre is still very accurate and is a Great Naval Painting and copies will be donated to the United States Naval Academy museum, the United States Naval War College museum and the new Naval Historical and Heritage Command museum in Washington DC. The video and supporting documentation have been sent off to our webmaster and we hope that this will be on our web site in the very near future.
